FEE AND REGISTRATION INFORMATION

FEES:

- Returning Family Registration Fee*** (due with registration) \$80.00 per family
 - First Time Registration Fee*** (due with registration) \$100.00 per family
- (First Time registration fee is paid in the year that the family enrolls their 1st child at St. Mary Catholic School. In subsequent years, they are assessed the registration fee for Returning Families.)*
- Information & Technology Fee for Grades Pre -K thru 8** (due July 15, 2018) \$100.00 per family

**The registration fee is non-refundable unless your child is not accepted for enrollment.*

REGISTRATION INFORMATION:

STEP 1. Please check your level of tuition based on your parishioner status and the number of children who will be enrolled at St. Mary Catholic School for the 2018-2019 academic year.

STEP 2. Sign the tuition agreement and return **with your registration fee** to St. Mary Catholic School on or before Friday, May 4th. *If you are not current with tuition and fees, your registration cannot be processed.*

TUITION AGREEMENT

Six options for payment are available and are provided. Please initial your payment plan preference and sign the form on the designated line. You will be billed accordingly. *If no payment plan is initialed, you will be billed on the 10-month plan.*

Please consider Option 5, Automatic Charge Credit Card or Debit Checking Account, as a way to pay your tuition and fees. Option 5 can be used with any of the four tuition payment plans—advanced discount, quarterly payment, 10-month or 12-month. This would be of great help to the business office. Thank you.

Tuition Assistance is available to students whose parent(s) are registered contributing members of the parish and are unable to pay full tuition. Please complete the enclosed financial aid application and return the registration form, the application, and a copy of your 2017 Federal Tax Return to the School Office in an envelope marked "Tuition Committee – Confidential". You will be notified by letter upon approval for financial aid. Your application and inquiry will be kept confidential.

TUITION ASSISTANCE APPLICATIONS MUST BE SUBMITTED BY Friday, MAY 4th.

Option 1: Advance Discount Plan— Tuition: Total in Advance Initial Here _____

In consideration of a 3% tuition discount, the first and only tuition payment, Option B Scrip payment, and information and technology fees are due on July 15, 2018. The 3% discount applies only to tuition. It does not apply to registration or information and technology fees or to the Option B Scrip requirement.

Option 2: Four-Payment Plan— Tuition Increments 1/4 Initial Here _____

The information and technology fee, first tuition payment, and first Option B Scrip payment are due by July 15, 2018. Remaining tuition and Option B Scrip payments are due on October 15, 2018, January 15, 2019 and April 15, 2019.

Option 3: 10-Month Plan— Tuition Increments 1/10 Initial Here _____

The information and technology fee, first tuition payment, and first Option B Scrip payment are due by July 15, 2018. Remaining tuition and Option B Scrip payments are due on the fifteenth of each month thereafter, with the final payment due on April 15, 2019.

Option 4: 12-Month Plan— Tuition Increments 1/12 Initial Here _____

The information and technology fee, first tuition payment, and first Option B Scrip payment are due on July 15, 2018. Remaining tuition and Option B Scrip payments are due on the fifteenth of each month, with the final payment due June 15, 2019.

Option 5: Automatic Charge Credit Card or Debit Checking Account Initial Here _____

Please submit completed authorization form (enclosed) with the Tuition Agreement. The charge/debit will be made per the schedule of the tuition plan that you choose (Options 1 – 4)

Option 6: Financial Aid— Tuition Increments as agreed Initial Here _____

The information and technology fee, Scrip requirement and tuition will be payable according to the schedule agreed upon by the Tuition Committee. A financial aid application must be attached to this application in order to select this option. (Financial Aid is available to students whose parent(s) are registered contributing members of Basilica of St. Mary of the Assumption and are unable to pay full tuition.)

**Tuition and all fees for the current year must be paid in full before registration for the 2018-19 academic year will be accepted.*

**Any account delinquent over ninety (90) days will result in student report cards being withheld until the account is brought current. The final report card for the year will be withheld until tuition and fees are paid in full. If an account is delinquent over one hundred eighty days (180), an option that may be considered is the removal of the child from St. Mary Catholic School. When a student transfers to a new school, no records – including transcripts – will be released until fees and applicable tuition are paid in full.*

Scrip Requirement (for all families)

(Please initial option of choice)

Option A. For one child family, earn \$100.00 of Scrip rebate. For two or more children, earn \$120.00 of Scrip rebate. Rebates must be earned by June 30, 2019.

Option B. If Scrip rebate requirements are not met, parents will be required to pay an assessment of \$300.00 per year for one child or \$350.00 for two or more children. If a partial Scrip rebate is met, the assessment will be prorated according to the amount of the rebate met.

In consideration of enrolling my child(ren) in St. Mary Catholic School, I hereby agree to pay tuition and fees in accordance with the stated schedule according to the payment plan selected and fulfill either Option A or Option B of the Scrip requirement. I understand that I have an obligation to work Saturday bingos as scheduled if I am a Basilica of St. Mary of the Assumption Parishioner.
